Effect of Signature: By signing this Application and submitting it, the Contestant represents and agrees that (1) all facts and representations contained in this Application and Contract and its attachments are true and accurate; (2) the Contestant agrees to abide by all rules and regulations of the Lea County Fair Board described in this Application and its attachments, in the period before and during the year of service; and (3) the Contestant meets each requirement for eligibility set forth in the regulations; and (4) the Lea County Fair Board shall have the sole discretion to determine whether, in its judgment, the Contestant may continue to participate in the program, in the event that the Lea County Fair Board determines that any statement or representation by the Contestant is not true and accurate or that any action by the contestant is inconsistent with the rules and regulations of the program; and (5) other than minor, petty or traffic offenses, the Contestant has never been convicted of any criminal offense and there are no criminal charges presently pending against the Contestant; and (6) the contestant does no use or consume any illegal controlled substances or engage in the illegal use of alcohol or other dangerous substances. Contestants will not be allowed to curse, smoke, drink alcoholic beverages or be under the influence of narcotics at anytime after their application is received, during any mandatory and/or public function and after the crowning. Any unsatisfactory behavior can and/or will be cause for dismissal of contestant and relinquishment of title and/or any awards.

In that event, the remainder of this Application and Contract shall remain in full force and effect.
